- Mine Winders, cages, skips, winding ropes, and attachments.
- Main Centrifugal and Screw Compressors and pipe columns.
- Main Surface ventilation fans.
- East & West Refrigeration plants, including BACs.
- Shaft headgear, surface silos, load-out stations, shaft stations, and vertical shaft infrastructure.
- Surface mine water ponds.
- All UG main pump stations, settlers, and mud presses.
- All UG tips, structures, rock breakers & finger raise chutes.
- Diesel generators.
- Surface & UG mechanical workshops.
- Conveyor belts.
- Fire hydrants and sprinklers.
- Lime and flocculent dozing plants.
