# Finance Specialist

As a federal enterprise, GIZ supports the German Government in achieving its objectives in the field of international cooperation for sustainable development.

The "Support to East African Market-Driven and People-Centred Integration" (SEAMPEC) programme supports the East African Community (EAC) integration process that focuses on the needs of the private sector as well as on social aspects. SEAMPEC is funded by the German Federal Ministry for Economic Cooperation and Development (BMZ) and jointly steered and implemented by the EAC Secretariat and the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ).

SEAMPEC works – among other areas - to improve framework conditions for economic growth in the EAC, e.g. by removing identified trade barriers and assisting the business sector in developing policy recommendations. Furthermore, the programme assists selected economic sectors in their implementation of regional agreements that improve framework conditions for increasing value-addition. ## **Responsibilities and Tasks**

The Finance Specialist is expected to carry out the following tasks and services:

- financial planning, monitoring and accounting for GIZ-assisted projects
- Cost output reporting KOMP
- Contract Monitoring
- prepares monthly and annual budgets and monitors deviations
- Planning and steering on cost basis KOMP (Onsite Reporting)
- Preparation of financial reports for co-financings
- Service package checks for correct booking
- Cost and expenditure rebookings
- Support preparation and execution of Internal control
- External audit management and follow up Audit report with partner
- Contract monitoring and management (e.g. Obligos, Shedule of finance, upcoming payments, Contract Finalization)
